ADOPT-A-PARK PROGRAM  
WAIVER OF LIABILITY



In consideration of being allowed to participate in the Adopt-a-Park litter collection program, the undersigned hereby assumes any and all risk of injury, damage or loss, either to the undersigned's person or property, from all and every cause, including both affirmative and passive acts of negligence, violation of law, or willful misconduct on the part of the person who completed the application for participation in the program, myself, other participants, members of the public, or the City of Redding, its officers, employees, or agents, during such litter collection, as an incident thereto, or in connection therewith.

It is the understanding between the undersigned and the City of Redding that neither the City of Redding, nor its Community Services Department, nor any of its officers, employees, or agents, shall incur liability or obligation to the undersigned, his/her heirs, successors or assigns. Neither the City of Redding nor its Community Services Department makes any promises, guarantees, or warranties nor enters into any obligation to undertake any action on behalf of the undersigned other than to permit him/her to participate in the Adopt-a-Park program in accordance with the conditions of the completed application pertaining thereto.

I agree to indemnify, defend and save harmless the City of Redding, its Community Services Department, and its officers, employees and agents, from any and all claims, suits or actions of every name, kind and description, brought for, or on account of, injuries to, or death of, any person or damage to property resulting from my performance of any work while participating in this program, as an incident thereto, or in connection therewith.

In the event any provision of this Waiver of Liability is declared null and void by any court of law, the remainder of the provisions of the agreement shall remain in full force and effect.

I acknowledge that I have attended a safety orientation, including an explanation and discussion of the safety requirements for the Adopt-a-Park Program, and that I have read the above Waiver of Liability, that I understand it, and that I am voluntarily signing it.
