All appeals must be received by the Redding City Treasurer's Office at the address shown above **WITHIN 21 CALENDAR DAYS FROM THE DATE OF ISSUANCE OF THE PARKING CITATION OR 14 CALENDAR DAYS FROM THE DATE OF MAILING OF THE NOTICE OF DELINQUENT PARKING CITATION.** To contest a Parking Citation, complete Section A below. If you admit the violation but believe good cause exists to excuse the violation, please describe the circumstances surrounding the violation. If you deny committing the violation, you must provide factual evidence to support your position prior to the administrative hearing.

A late payment penalty of \$20 will be added to the citation penalty amount if payment is not timely remitted. All unpaid citations are referred to the DMV for collection.
